Member Garcia said her concern is whether it is an internal process to ensure that we spend the dollars that will expire sit. She asked what will happen to the \$1.8 million remaining balance. Ms. Ramos replied that this is one of the three allocations for learning loss mitigation. It has a later expiration date and has not yet been committed. Member Garcia then asked w\$\$20,000 in the unrestricted general fund that was spent on professional development could not be covered with CARES Act dollars. Mr. Turkie answered that these are for stipends that people would receive a(toutside of COVID-19), such as for athletidirector.

Vice President Pritchett seconded Member Murawski's motion to approve the item. The motion passed unanimously.
