<u>Background/Rationale</u> : SCUSD's Facilities Department is applying for a CAL-Fire Urban & Community Forestry Program-funded Green Schoolyards grant, which we have named: Building Climate Resiliency Through Schoolyard Equity. Thirteen campuses are represented in the \$30-million, 3-year grant program. Each site can receive up to \$2.5 million over the grant period. The thirteen\$30 million grant to reimburse bond dollars upon regular invoicing
